I welcome all of you to the 3 4 public hearing for the draft revisions to the 5 Admissions and Continued Occupancy Policy and Lease 6 Agreement for Legends South Phase C3. The purpose 7 of this hearing is to receive comments on the 8 proposed documents before presenting them to the 9 Board of Commissioners for approval and submission 10 In addition to voicing your comments here to HUD. 11 tonight, residents and the community at large have 12 the opportunity to submit written comments to CHA 13 during the comment period, which began on February 14 26 and goes to March 28. Copies of the proposed 15 documents are available on the website. We have also brought copies here for outside viewing. 16 17 If you have not already done so, please 18 sign in at the registration table before you leave tonight. - 5 after the public comment hearing.
- Before we open the floor for comments, I
- 7 have Lauren Shepherd to walk you through an overview
- 8 of the development.
- 9 MS. SHEPHERD: Hi, I'm Lauren Shepherd and I'm
- 10 with Michaels Development. Just to give a brief
- 11 overview, this is an offsite of things of Legend
- 12 South, and it's as you can see from the site plan,
- it stretches from 43rd Street down to just about
- 14 45th Street and from South Michigan Avenue to South
- 15 Prairie.
- There are 71 units in the development,
- 17 and there are six different building types which you
- 18 can again see there on one side of the board. In
- 19 terms of unit mix, there are 21-one bedrooms, 27-two
- 20 bedrooms, 20-three bedrooms, and 3-four bedroom
- 21 units in the development. There are 18 market rate
- 22 units, 23 tax credit units, and 30 CHA units. We
- 23 also have a management office which will be included
- of about 2400 square feet and commercial space of

- 1 about 1600 square feet. Both of those are in
- 2 buildings on 45th Street. That's about it.
- 3 MS. LEE: Thank you. All right, as we prepare
- 4 the floor for comment, I want to remind everybody
- 5 that they have an opportunity to voice their
- 6 comments here tonight or submit written comments via
- 7 email or US mail. And they're accepted through the
- 8 comment period which end March 28. If you would
- 9 like to speak tonight, we need you to fill out a
- 10 green speak card located at the front of the desk.
- 11 While we open the floor for comments, one name will
- 12 be called at time.
- 13 Please be prepared to comment on the
- 14 proposed documents. Each person will have two
- minutes and will ring a bell when 30 seconds remain.
- 16 Each person is able to have the time yielded to
- 17 another speaker, and each speaker may only yield
- 18 additional time once for a total of four minutes.
- 19 With that I'll open the floor for comments on the
- 20 draft revisions to Legend South Phase C3.
- 21 Any comments tonight? Given there is no one here to
- 22 make any comments, I will call this meeting to a
- 23 close. I want to thank everyone for coming tonight.
